A couple of weeks ago, a letter came to the church in the mail from the Presbyterian Foundation. It was to inform the session and the congregation that we were the beneficiaries of a Charitable Remainder Trust set up by John and Carole Riedmaier. This was unexpected, but also not a

surprise. No one told us that this had been set up, but this was not out of character for John and Carole, who were very aware of their impact on Living Hope and wanting to prepare for the future.



A Charitable Remainder Trust is a legal arrangement where you put assets into a trust that has tax advantages and provides a regular disbursement to you over the course of your life. When you die, the amount that is left in the trust then passes on to the organization that you designate. John and Carole set their trust up so the interest from their investments would provide a regular stream of income for Living Hope for years to come.

The Presbyterian Foundation is an agency of the Presbyterian Church (USA) based in Indiana. It was incorporated in 1799 to provide a way to safeguard the long-term financial interests of the Presbyterian Church, it's congregations, and the mission of the church. The Foundation has representatives in this region who are available to answer questions about Charitable Remainder Trusts and other investment options that may suit your desire to provide continued support to Living Hope or other charitable causes.

While John and Carole have left us in body, their spirits and gifts live on, providing support and encouragement for years to come. May we all find hope in the fact that our legacies do continue and we are surrounded by a great cloud of witnesses who have walked this life in faith.

A Note from Food for the Journey

The following article is from the pastor at Apostle Presbyterian Church, the founding church of Food for the Journey ministry. The other participant churches are: Kettle Moraine United, Jerusalem -Wales, Delafield, North Shore - Shorewood, Calvary - Milwaukee, and Living Hope.



The FOOD FOR THE JOURNEY garden is planted again this year, the second year for this effort. As I stood by the garden two different days last week, I started to think about ALL of the things that have happened because of this wonderful ministry.

Ray is a 15-year-old boy who started coming to our Wednesday outreach at Apostle to get food for his family. He lives within blocks of the church but needed help getting things home, so I started taking him home each week. He shared with me that he was vegetarian and when vegetables started coming in from the garden, he is incredibly happy and thankful. As we drove week after week, I learned many things about Ray and his family, folks I had known since I came to Apostle in 2011. His mother was dying (and did die in March), his sisters were struggling in different areas of their lives but when Ray told me he was going to drop out of school because he was so far behind in his work, I knew something needed to be done. We have a school in our building called Shared Journeys; it is for teenage moms and dads and their babies. I approached the teacher at Shared Journeys to ask how I could help Ray best; she immediately reached out to the leadership in our school district to ask if Ray could attend Shared Journeys despite the fact, he didn't fit in the category of students we have. The answer was YES. Ray started attending in February; today he sent me a picture of his progress thus far; he is totally caught up AND is even ahead in some of his work. He has more self confidence than he has had in the past. When his mother died, the students surrounded him in love and generosity that was simply beautiful to see.

Without the garden, none of this would have happened for this young man. While we believed this was about feeding people and it IS, there is also a relationship piece to this project that serves others as well.

I am so grateful to everyone who is helping with the garden. We never know who we are helping and how!!


Welcome New Members


